Reports to: Charge Nurse

Purpose: The Registered Nurse provides professional nursing services for the care and treatment of patients. The Registered Nurse assesses, plans, implements, and evaluates individual patient care according to policies, procedures, and standards of care. Accepts responsibility for the supervision and direction of co-workers in the implementation of the nursing care plan. Will be required to work in other areas, especially PACU. Performs other duties as assigned.

Functions:

All functions are essential unless otherwise noted.

- A. Assesses patient.
- B. Develops a plan of care based upon the assessment of the patient.
- C. Implements plan of care.
- D. Evaluates patient's response to care and updates care plan.
- E. Documents assessment, plan, all care administered, and patient's response in the medical record.
